

MADRID, Spain (UPI) — Suspected Basque separatists today bombed a nuclear power plant being constructed near the city of Bilbao, killing and injuring several people, police said. A spokesman for the Iberduero company which owns the Lemoniz power plant said at least two people were killed and 10 injured. The national Spanish radio network reported three dead and five

The Lemoniz plant has been the target of demonstrations and an earlier armed attack by members of "Basque Homeland and Liberty," a guerrilla organiza-

White told Bryant what the government expected to show if the trial had gone on as scheduled.

"In return for his efforts, Hanna received many benefits," White told the judge. "He received in excess of \$200,000 in cash and checks between 1969 and the end of

That is twice as much as previously published estimates of money that Hanna received from Park. In the course of congressional hearings, Park has denied bribing any congressmen or in any way acting as an agent of the Korean government.

Hanna's plea came on the day when the government was to present its first witnesses in the trial of the only other man charged with crimes in the Korean scandal, Hancho C. Kim, a Korea-born cosmetics salesman also charged with defrauding the government.

White told Bryant that there is no evidence Hanna paid any money to any other congressman.

Hanna's role as outlined by the Justice Department attorney was to help Tongsun Park become seller's agent for California rice to Korea, thereby enabling Park to earn substantial commissions.

Hanna also recommended to the director of the Korean Central Intelligence Agency and other Korean government officials that Park be designated as agent of the California rice sellers, White said. Hanna then introduced

## S.C. Pair Nabbed For Ford Threats

COLUMBIA, S. C. (AP) - Two Columbia men were taken into custody by the U.S. Secret Service yesterday after they allegedy threatened former President Gerald Ford.

There was no indication Ford was aware of the arrests, which occurred late in the afternoon as Columbia police helping guard Ford said they heard the two make threatening statements. Officers said the alleged remarks were made on a street near the downtown Wade Hampton Hotel where Ford was staying and that they were arrested in the

Ford arrived in Columbia yesterday for a three-day series of lectures and other appearances on the University of South Carolina campus.

The two were identified by the Secret Service as Roger M. Dent, 20, and Raul T. Sanchez, 21. The specific charges against them are interfering with a federal agent in the performance of his duty.

They appeared before U.S. Magistrate Charles W. Gambrell today and were placed under \$25,000 bond.
